After analyzing your request, we consider that the following document fall within its scope:

After examining this document in accordance with the provisions of Regulation (EC) No. 1049/2001 on public access to documents and taking into account the opinion of third parties from whom certain parts of the document emanate as per Articles 4(4) and 4(5), we have reached the following conclusion:

Amendment n ° 1 to grant agreement n ° INEA / CEF / TRAN / M2014 / 1057372, may be partially disclosed.
